Fact Sheet for suppliers, to pick up 0-km complaints



Dear Supplier of BAUER Maschinen GmbH,

In order to guarantee a smooth process of picking up 0-km complaints for you and for us, we would like to draw your attention to the most important rules and regulations for picking up 0-km complaints from our plants. Safe and smooth loading in our plants is only possible on observing the points listed below.

Please be sure to observe them.

Collection addresses

The pick-up location is mentioned in the defect report.

Delivery address

 Goods receipt Schrobenhausen plant: Bürgermeister-Götz-Straße 32 - 36 (Exceptions only by prior arrangement)

Collection times

- The loading times in the above mentioned plants are:
 - Monday to Thursday, 7 a.m. to 4:30 p.m. Lunch break, 12 noon to 1 p.m.
 - \circ Friday 7 a.m. to 1 p.m.
- No goods can be collected on statutory German federal or Bavarian state public holidays.
- The factory gates open at 7 a.m.

Collection

• <u>The 160-no. (9-digit). which has been communicated in advance by the</u> <u>Purchasing department – Supplier Claim Management must be specified.</u>

If picked up by an external carrier (such as UPS, GLSG, TNT etc.), please note:

- This fact sheet must be forwarded to the external carrier.
- Ensure that the already mentioned **<u>160-no. has been received</u>** by the external carrier.

Technical condition of the vehicles

- Collecting vehicles must be in a technically fault-free condition, comply with all legal requirements, and be equipped with the necessary technical means to transport the goods (e.g. adequate numbers of lashing points).
- Vehicles that are subject to approvals must have valid transport documents.
- The papers must be presented unsolicited to the dispatch personnel prior to loading.
- Loading will only take place after the papers have been checked.
- The legal requirements for transport within Germany must be observed.
- The load must be secured by the driver in accordance with the regulations.
- Vehicles with inadequately secured loads must not be allowed to leave the plant.
- The necessary fixtures and fastenings must be carried on the vehicle in sufficient quantities and in technically fault-free condition; this includes, in particular:
 - Anti-slip mats
 - Lashing straps
 - o Chains

Rules of conduct on the factory premises of BAUER

- Drivers must report to the security staff at the gate when entering and leaving the site.
- Vehicles must only be parked in the assigned bays.
- Drivers are not permitted to move freely around the factory premises. They must remain in/at their vehicle.
- Drivers must wear safety shoes and a safety helmet during loading and unloading. This requirement is for their own safety.
- The following are not permitted at our plant locations:
 - Consuming alcohol
 - Sleeping overnight
 - Disposal of waste or cleaning vehicles
- The driver has to undergo the controls necessary to maintain order and safety when entering and leaving the premises.
- Instructions from Bauer personnel must be followed.

We request you to comply with the above points in order to ensure safe, quick and smooth loading.
